THIS YEAR, WE HAVE LAUNCHED A NEW WEEKLY SPANISH-LANGUAGE SURVIVOR SUPPORT GROUP, A MONTHLY TRAUMA-INFORMED YOGA CLASS, A FIVE-SESSION WRITING WORKSHOP FOR SURVIVORS, AND ART-INFORMED HEALING SUPPORT GROUPS.

INVESTIGATIVE TEAMS FOR CHILDREN: THE CENTER SEXUAL ASSAULT CRISIS COUNSELING AND EDUCATION IS AN INTEGRAL PART OF THE 2 CHILD SEXUAL ABUSE RESPONSE TEAMS (MDT) SERVING OUR AREA. THEY ARE MULTI-AGENCY INVESTIGATIVE TEAMS COMPRISED OF SEVERAL AGENCIES: CHILDREN'S CONNECTION, CHILD GUIDANCE CENTER, DEPARTMENT OF CHILDREN AND FAMILIES, LOCAL POLICE, STATES ATTORNEY'S OFFICE AND OTHERS.
